10 Overview and aims

This module forms the core of the creative writing pathway within the BA (Hons) English with Creative Writing at Level 1. It introduces a range of topics and texts that focus on key aspects of writing practice. Students will be encouraged to experiment in the writing of narrative and to develop skills in critical feedback. Aims of the module are:

- to encourage students to study and participate in the practice of writing
- to facilitate experimentation and verbal creativity in students' own writing
- to encourage critical reflection on students' own reading and writing practice

to develop students' use of appropriate critical and editorial tools in relation to their own work and that of other writers

11 Module content

The module will introduce students to the core elements of writing fiction and creative non-fiction, such as narrative structure, characterisation, dialogue, editing and revision of text as well as looking at a range of different genres and styles of writing. Links might be made to literary material studied on other Level 1 modules. Students will also be helped to develop essential skills in the giving and receiving of criticism. There will be both whole and small group workshopping. Students will develop independent learning strategies in relation to researching and drafting their creative work. They will also develop the ability to work in groups to make use of independent strategies to use information resources effectively.

A typical course outline is:

- Starting to write
- Keeping a writer's journal
- Establishing points of view
- Developing character(s)
- Understanding of narrative structure
- Using dialogue
- Locating a sense of place
- Use of symbolism, myth and metaphor
- Experimentation in a range of genres and styles
- Editing and revising texts
