10 Overview and aims

This module focuses on how decisions about migration, environment and development are made within the EU and the impact that they have, both within and outside Europe. It begins by looking at how EU decisions are made: how do issues arrive on the EU agenda; which actors play the most important roles; how do the institutions interact with organised interests, with international organisations and with member states; how are the issues framed by the various actors involved; what are the major policy outputs; and what impact do they have? Migration, environment and development are used as case studies to explore these aspects of European policy-making.
