- •To analyse the transition from collectiveness to individualism since China's open policy, and its impact on Chinese society
- •Improve knowledge and understanding of the background issues, processes and themes relevant to an understanding of contemporary China

11 Module content

This module is an introduction to Chinese studies. It aims at an understanding of Chinese culture as practised in the tradition and contemporary society. It introduces the background knowledge of modern China, including aspects such as history, geography, ethnicity, language and dialect, education, as well as socio-cultural aspects of other Chinese speaking communities, which provides a framework for the study of Chinese politics, economics and society in year 2. Cultural differences between the West and East in general and between Britain and China in particular will be highlighted where appropriate. The module is taught in English.
