### 10 Overview and aims

This module will consider the contested history and memory of the American Civil War. It will examine the diverse and often divisive ways in which sections of American society have remembered the events and issues surrounding the War. Students will explore the ways in which memories of the War have been constructed and how these constructions have been contested and changed over time. In so doing, they will explore the political, social and cultural meanings of memory. Students will not only deepen their knowledge and understanding of American History from the nineteenth through to the twenty-first centuries but will also explore ideas about national and public memory, race, gender, sectionalism and historiography.
