10 Overview and Aims

The aim of this module is to examine the politics and government of the USA - a complex and changing western liberal democracy. Students will be introduced to the significant actors and institutions in the political and governmental system of the United States. Their de jure and de facto powers along with their roles and functions will be discussed and critically evaluated in a range of policy areas.

11 Module Content

The following topics will be studied: The historical context of the USA before the Revolution, the American Revolution, the creation and political impact of the US Constitution, the federal system, US politics in the 19th and 20th century, political parties, interest groups, the electoral system, the impact of African-Americans and Hispanics on American politics and society, the Presidency, Congress, the Supreme Court, the federal bureaucracy, policy creation, pluralist and elitist theories of US power, American foreign policy.
